

Approved Projects

The United Board is pleased to accept contributions in support of our work with our network institutions throughout Asia. Donors who wish to contribute for a purpose not listed below should contact us before making a gift.

In compliance with IRS regulations, the United Board can receive contributions for overseas institutions only for *approved projects* at those schools, not for general expenses.

- Capital projects (for specific building campaigns and campus rebuilding efforts in cases of fire, flood, natural disaster, and civil unrest)
- Faculty development support at specific institutions, such as for faculty scholarships and training; professional chairs, merit prizes, etc. (Please specific the exact name of the project.)
- Library support (acquisitions, online resources, etc.)
- Programs to support Christian presence on campus (campus ministry, chaplaincy programs, etc.)
- Programs that involve building networks and linkages with other institutions
- Service-Learning
- Student scholarships
- Support for a particular academic department (e.g., Biology Department)

The United Board monitors the appropriate use of all funds by requiring annual reports from the institutions about how grants received from the United Board, including designated grants, are used
