



Former United Board Trustee

Former Member and Chair, Board of Trustees

Dr. Judith Berling's service as a trustee inspired her to join the United Board Legacy Society by including the United Board as a beneficiary of her IRA retirement plan. Dr. Berling is professor emerita of Chinese and comparative religions at the Graduate Theological Union in Berkeley, California. She began her two decades of service to the United Board when she joined the board of trustees in 2002. Her service has included many leadership roles, including as Chair of the board from 2018-2021. Key developments she's seen in that time include increased participation by Asian trustees, continued attention to less developed regions and institutions, and greater emphasis on whole person education.

"I have been fortunate to have been a scholar and teacher during a time when the intellectual world was exploding with new theories and approaches," says Dr. Berling. "I'm making a legacy gift to give the United Board the flexibility and resiliency to help higher education in Asia continue this progress in the next 100 years."



Dr. Dorothy C. Wong

United Board Scholarship Recipient

Dr. Dorothy C. Wong received a United Board scholarship for her undergraduate education at International Christian University (ICU) in Japan from 1977 to 1981. This scholarship program supported 112 students from Hong Kong for over 30 years. Her interests in art history, literature, and



philosophy were expanded at ICU, leading Dr. Wong to later earn a PhD in art history from Harvard University and take a faculty position with the McIntire Department of Art at the University of Virginia, where she currently teaches.

In addition to supporting the United Board's programs in women's leadership, Dr. Wong has made a legacy gift pledge in recognition of the support provided by the scholarship she received and its deep impact on her career path. She shares that "The United Board Scholarship offered me a path to a liberal arts education, the value of which I did not fully understand until many years later."
